**MOTION FOR PARTY STATUS OF THE CALIFORNIA INDEPENDENT  
SYSTEM OPERATOR CORPORATION**

Pursuant to Commission Rules of Practice and Procedure 1.4(a)(4) and 11.1, the California Independent System Operator Corporation (CAISO) hereby moves for leave to become a party to this proceeding.

The CAISO is a California not for profit public benefit corporation charged with reliably planning and operating the high voltage transmission system for its participating transmission owners. The CAISO is an active participant in many Commission proceedings, including the Commission’s Resource Adequacy and Integrated Resource Planning proceedings.

In this proceeding, the Commission seeks party feedback on the Coalition for Community Solar Access (CCSA) proposed Net Value Benefit Tariff (NVBT) and other topics related to the consideration of a community renewable energy program. The Commission’s *Ruling Setting Aside Submission of the Record to Seek Comments on Aspects of Net Value Benefit Tariff Proposal*, issued on November 6, 2023, seeks additional party feedback on the NVBT proposal regarding grid reliability and capacity values, guardrails, and interconnection.

The CAISO can provide unique input on these issues. Projects considered under the NVBT proposal may be large resources that export energy, creating backfeed onto distribution and transmission systems. The CAISO has an interest in providing feedback on issues that may impact CAISO operations and grid reliability. The CAISO requests the Commission grant the CAISO party status to allow it to participate in this proceeding
