FERC Order No. 2222**

Dear Secretary Reese:

On July 19, 2021, and amended on November 2, 2021, August 15, 2022, and January 10, 2023, the California Independent System Operator Corporation (CAISO) submitted a tariff amendment to comply with FERC Order No. 2222. By order issued May 18, 2023, the Commission accepted these tariff amendments. The first batch was effective on June 16, 2022, and the Commission directed the CAISO to submit an informational filing to inform the Commission of the actual effective date of the remaining items within five (5) business days of the planned implementation of November 1, 2024.¹

The CAISO implemented the remaining items on November 1, 2024. Accordingly, the CAISO is submitting this informational filing to specify an effective date of November 1, 2024 for the tariff revisions accepted by the Commission in this docket for the supplementary compliance filing tariff records.² This action completes the CAISO's compliance with Order No. 2022.
