Reference: Energy Imbalance Market Service Agreements

On October 1, 2021, California Independent System Operator Corporation (CAISO) filed six individual service agreements between CAISO and Bonneville Power Administration (Bonneville). CAISO states that the service agreements set forth the legal obligations and operational rules for Bonneville's participation in CAISO's Energy Imbalance Market. Pursuant to authority delegated to Director, Division of Electric Power Regulation – West, under 18 C.F.R. § 375.307 (2020), the service agreements are accepted for filing, effective December 1, 2021, as requested.<sup>1</sup>

This filing was noticed on October 1, 2021, with comments, protests, or motions to intervene due on or before October 22, 2021. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214 (2020)), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted. Granting a late intervention at this
