**MOTION FOR EXTENSION OF TIME  
OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION  
TO FILE DECEMBER 2008 MRTU STATUS REPORT**

Pursuant to Rules 212 and 2008(a) of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission (FERC or the Commission), 18 C.F.R. §§ 385.212, 385.2008(a), the California Independent System Operator Corporation (CAISO) respectfully submits this motion for an extension of time in which to submit its monthly status report in compliance with Paragraph 1415 of the Commission’s September 21, 2006 “Order Conditionally Accepting the California Independent System Operator’s Electric Tariff Filing to Reflect Market Redesign and Technology Upgrade,” 116 FERC ¶ 61,274 (2006) (September 21 Order), issued in the above-referenced docket. As explained below, the CAISO requests a seven-day extension of time, to file no later than December 8, 2008, to submit its status report for December 2008.

Paragraph 1415 of the September 21 Order requires the CAISO to file monthly reports addressing the progress that has been made in designing and implementing the CAISO’s Market Redesign and Technology Upgrade (MRTU) and the status of the CAISO’s MRTU readiness program. The CAISO generally submits this report on the first Monday of each month. However, the CAISO

requests leave to file the December 2008 monthly report shortly after December 1, which is the first Monday of that month, because it requires additional time to prepare a monthly report that fully reflects recent discussions with stakeholders on MRTU issues and the direction provided by the CAISO Governing Board at its November 24, 2008 meeting. In order to provide the Commission and interested parties with the most up-to-date information available regarding the status of MRTU, the CAISO respectfully requests a seven-day extension of time in order to be permitted to file the monthly report for December 2008 no later than December 8, 2008.
