On November 12, 2010, the California Independent System Operator (CAISO) filed revised tariff sections in compliance with the Commission's September 30 Order. Specifically, the CAISO proposes to: (1) modify the effective date of certain tariff sections from October 1, 2010 to November 15, 2010, (2) strike the word "amount" after the term "Minimum Load" in sections 11.8.2.1.7.1 and 11.8.3.1.4.1, and (3) substitute the term "Transition Cost multiplier" for the term "Transition Costs index" in section 30.4.2. The revised tariff sections are accepted for filing, effective November 15, 2010, as requested.

Notice of this compliance filing was issued on November 1, 2010 with protests, comments, or motions to intervene due on or before November 19, 2010. No protests, or comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any unopposed or untimely filed motion to intervene is governed by the provisions of Rule 214.

This acceptance for filing shall not be construed as constituting approval of the

referenced filing or of any rate, charge, classification, or any rule, regulation or practice affecting such rate or service provided for in the filed documents; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or any which may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against the California Independent System Operator Corporation.

This action is taken pursuant to the authority delegated to the Director, Division of Electric Power Regulation – West, under 18 C.F.R. § 375.307 of the Commission's regulations. This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
