# OBJECTIONS TO PROPOSED TRANSCRIPT CORRECTIONS AND WITHDRAWAL OF A PROPOSED CORRECTION OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

The California Independent System Operator Corporation ("ISO") objects to several of the transcript corrections proposed by other parties in this proceeding on May 24, 2004, and withdraws one of its own proposed corrections.

#### I. Objections

The ISO objects to the following proposed corrections:

#### Southern California Edison

Southern California Edison ("SCE") proposed to change "E. Moore" to "J. Moore" on page 754, line 2, and page 789, line 15. In the first instance, the proper correction on page 754 is to replace "E. Moore" with "Kissel", as reflected in the proposed transcript corrections of the ISO, the State Water Project ("SWP"), and the Cities of Anaheim and Riverside ("Cities"). In the second instance, page 789, line 15 appears to be correct as originally transcribed. In any event, "J. Moore" (the undersigned) was not present at the hearing that day.

#### State Water Project

SWP proposed, on page 1023, line 10, to change "Lee's" to "LeVine's". The correct form of the ISO's witness' name is "Le Vine". With that alteration, the ISO does not object to this correction.

#### Withdrawal II.

The ISO proposed that on page 614, line 25, the word "not" be replaced with the word "need". Both SCE and the Cities, however, proposed that the word "not" be replaced with the word "want". The ISO does not object to these parties' suggestion, and thus withdraws its proposed correction on this line.
