The California Independent System Operator Corporation (“ISO”) moves to intervene and file comments in response to the notice of termination of a three party small generator interconnection agreement (“SGIA”) filed by Pacific Gas and Electric Company (“PG&E”) on September 25, 2013. The SGIA is a three-party agreement among and between PG&E, the ISO, and Crocker Solar Power, LLC.
