Reference: Energy Imbalance Market Service Agreements

On September 2, 2022, California Independent System Operator Corporation (CAISO) filed six individual Western Energy Imbalance Market service agreements (EIM Agreements) with Western Area Power Administration (WAPA).¹ CAISO states that the EIM Agreements set forth the legal obligations and operational rules that will govern WAPA's desert southwest region's participation in CAISO's Western Energy Imbalance Market. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – West, under 18 C.F.R. § 375.307 (2021), the EIM Agreements are accepted for filing, effective November 2, 2022, as requested.

The filing was publicly noticed, with interventions and protests due on or before September 23, 2022. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214 (2021)), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted. No protests or adverse comments were filed.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed documents; nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against CAISO.
