Dear Secretary Bose:

In compliance with the Commission's September 23, 2010 letter order in Docket No. ER10-1652-000, the California Independent System Operator Corporation re-submits the notice of termination of the Meter Service Agreement for ISO Metered Entities (MSA) between the ISO and the City of Corona, California, revised to specify an effective date of September 1, 2010.<sup>1</sup>

In the September 23 letter order, the Commission accepted the termination of the Corona MSA effective as of the closing date of the transfer of the Clearwater generating facility from Corona to Riverside. The order included a condition that the ISO submit the revised notice of termination to reflect the actual closing date of the transfer of the Clearwater facility from Corona to Riverside. The closing date for this transfer is September 1, 2010, and the enclosed revised version of the notice of termination reflects that date.

Enclosed for filing are each of the following:

- (1) this letter of transmittal; and
- (2) the notice of termination of the Corona MSA, with an effective date of September 1, 2010.
