ORDER OF CHIEF JUDGE REVISING TRACK II PROCEDURES

(Issued April 4, 2003)

1. On April 4, 2003, the California Department of Water Resources State Water Project (SWP), with the support of the Active Parties¹ in this proceeding requested that the Chief Judge revise the procedural schedule herein to permit the Commission the option to consolidate the California Independent System Operator Corporation's (CAISO) March 11, 2003, amendments to the CAISO Tariff (2003 TAC Amendments), in Docket No. ER03-608-000 with the instant proceeding. The Parties state that there is currently an unopposed motion pending before the Commission for consolidation of the two proceedings. The Parties further assert that modification of the procedural schedule will allow them to address the CAISO's recently proposed modification to its original TAC proposal in one consolidated proceeding.

2. The Chief Judge finds that a brief extension of the procedural schedule in this case will avoid duplication of resources and will result in administrative efficiency. Accordingly, for good cause shown, the procedural schedule herein is modified as follows:
