### California ISO Stakeholder Initiative Process



This represents the typical process, and often stages of the process run in parallel.

- Business Practice Manuals
  - ➤ The purpose of BPMs is to set forth business practices that implement the ISO tariff.
  - The ISO conducts a yearly policy initiative roadmap process to consider and rank initiatives.
    - ➤ Policy changes submitted though the PRR process will be referred to the policy initiative road map process.
  - Each subject area in a BPM is based on enabling language in the ISO tariff.
    - The PRR process cannot be used to introduce changes that are not supported by existing tariff authority.

#### PRR 1624 – Updating affiliate information and how they are associated

- Reason for revision
  - The reason for this revision is to clarify affiliate information and how that information is used by the CAISO. Adding clarifying language to show an umbrella when 3 or more companies have a single common affiliation.
  - Also updated attachment B to add additional questions for onboarding to recognize additional training needs.
  - This will be effective at the end of the PRR process.

## PRR 1626 – Activation of contingency-based flowgates in fifteen minute market

- Reason for revision
  - The CAISO will now enforce Transmission Constraints for active, contingency-based flowgates in FRP deployment scenarios in the FMM but not in the RTD.
  - Effective date is 5/15/2025.
  - PRR Placed on Hold 5/27/2025
- Recommendation comments: None
- Recommendation comment period expired: June 17, 2025
- Next step: On Hold



## PRR 1627 – Adding state of charge to flexible ramping awards determination

- Reason for revision
  - Currently, storage resources may be unable to deliver flexible ramping up awards due to lack of state-of-charge. This PRR update adds the Flex Ramp Up term to the state-of-charge formula, ensuring deliverability from storage resources. This PRR update also includes a minor correction to Section 6.6.2.3. This is an emergency PRR with an effective date 4/29/2025




#### PRR 1631 – Automated logic to achieve a market solution

- Reason for revision
  - This PRR introduces automated logic in the RTD/RTPD and STUC clearing processes that allows the market to identify resource constraints that will lead to a market disruption. The logic will relax these resource-level constraints to address the identified infeasibility in the market clearing process and thereby achieve a market solution. This logic effectively mitigates for market disruptions and eliminates the need to exclude resources from participating in the market.
