Stakeholder Engagement

Stakeholders represent energy markets across the western interconnect, and their input is essential to the ISO. Their representation ranges from, for example; transmission, market rules, policy initiatives, current on-going issues, settlements, and resource adequacy.

FERC has issued several orders emphasizing the importance of stakeholder engagement, see, e.g., Wholesale Competition in Regions with Organized Electric Markets, Order No. 719, 125 FERC ¶ 61,071 (2008).
