Additional Review of CRR Issues (continued)

- CRR issues discussed today that require rule changes will be presented to the CAISO Board in April except:
 - CRR Credit Issues will be deferred until the next Board meeting in late May; filing to FERC to follow in early June.
- Additional stakeholder discussion in late April to review the numerical value of the CRR credit margin.

- Use of Common Forecasts for Monthly CRR eligibility and Monthly Resource Adequacy (RA) Showings
- Frequency of Monthly Allocation and Auction Process
- CRR Transfers due to Load Migration

- 1. When will the CRR rules for allocation be "finalized?"
- 2. When will the CAISO want to receive source and sink data from LSEs participating in the allocation?
- 3. When will the CAISO want historic load data from LSEs participating in the allocation?
- 4. Could the CAISO identify the dates for:
 - a) allocation tiers for 2008 CRR's
 - b) dates for requesting LTR CRR's
 - c) date of 2008 auction.
