Targeted Audience: Market participants with the ability to submit bids for energy and energy-related commodities and services.

Details:

The California ISO is upgrading its WebSDK User Interface (UI) software framework from version 3.5 to 3.8 for multiple systems and applications. Market participants will notice a few changes to the user interface (UI) 'look and feel'. The new WebSDK 3.8 version may move familiar items around slightly, change the look of some elements or anchor UI elements in a different order. Please note that there are no core functionality changes to the Scheduling Infrastructure Business Rules (SIBR) application.

Below are some notable changes for SIBR UI:

UI Display updates

The CAISO logo shape will be oblong as opposed to rectangular.





Re-positioning of the **Apply/Reset** buttons on the main tabs to be closer to the fields on the left-side instead of the right-side.
