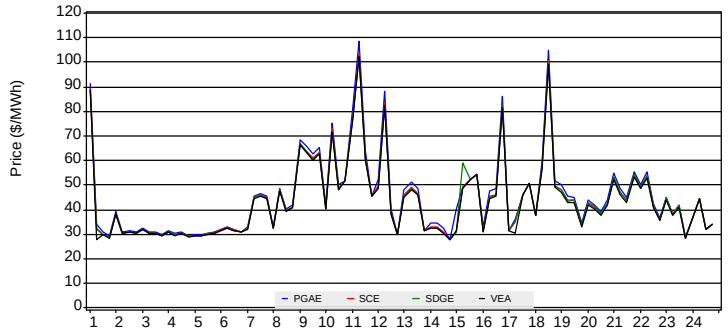

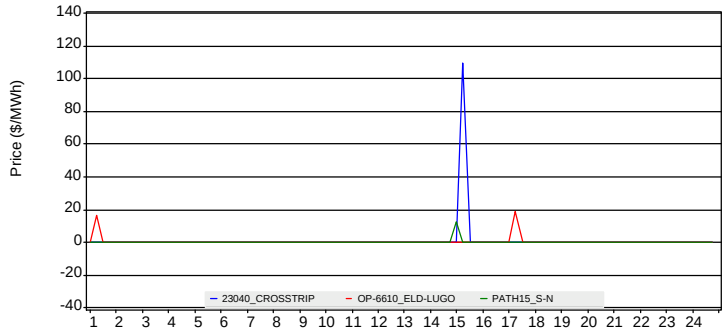

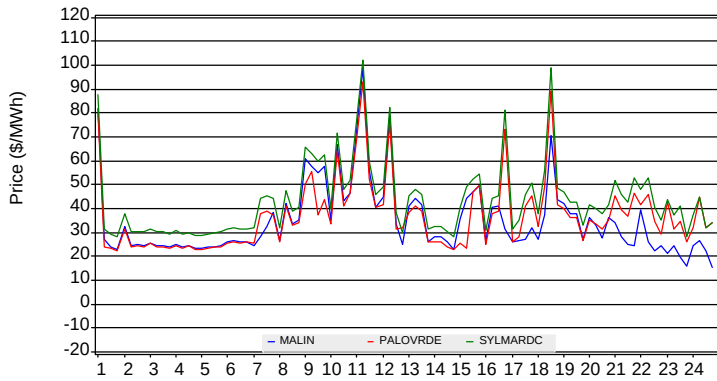

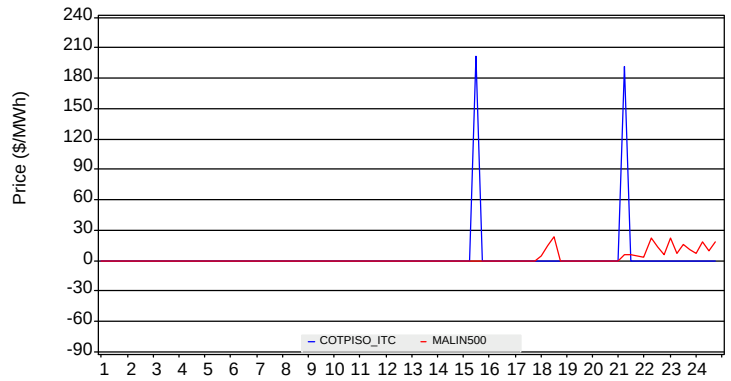

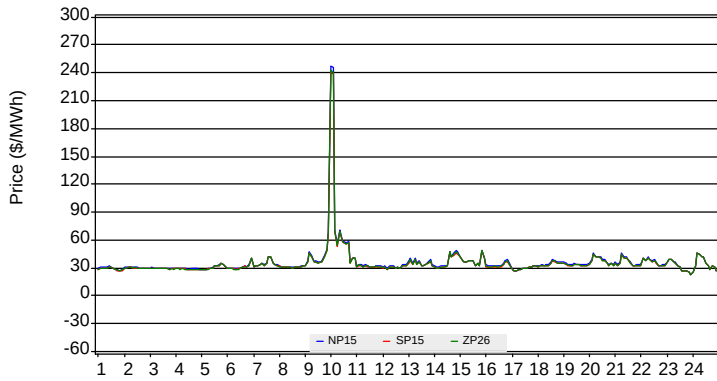
FMM Tie LMPs



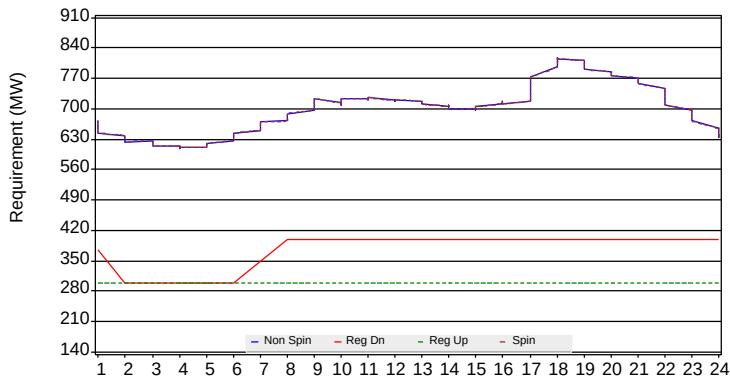
FMM Selected Tie point Shadow Prices



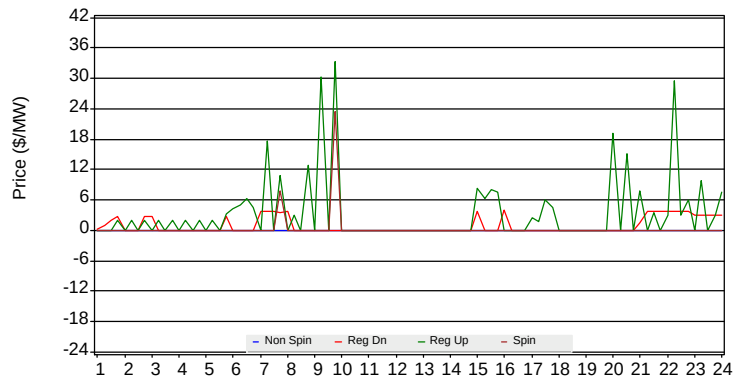
RTD Trading Hub LMPs

Average A/S Price

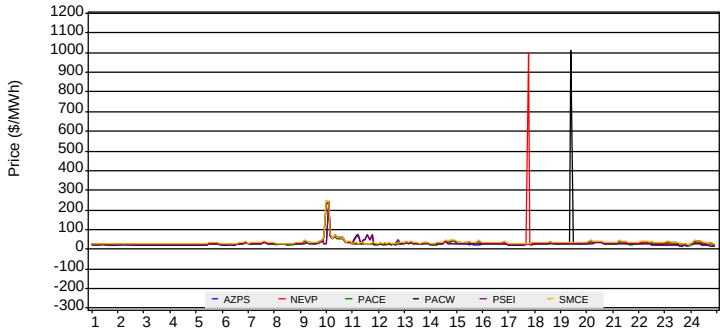

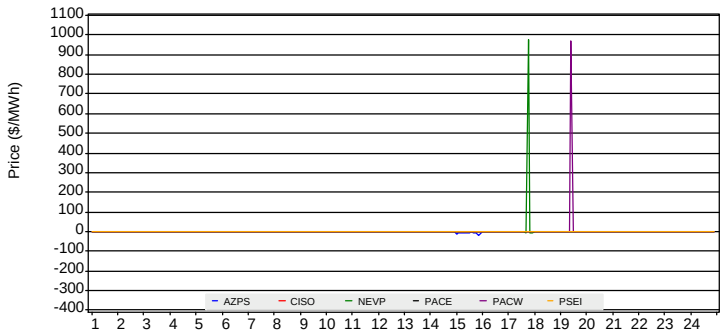

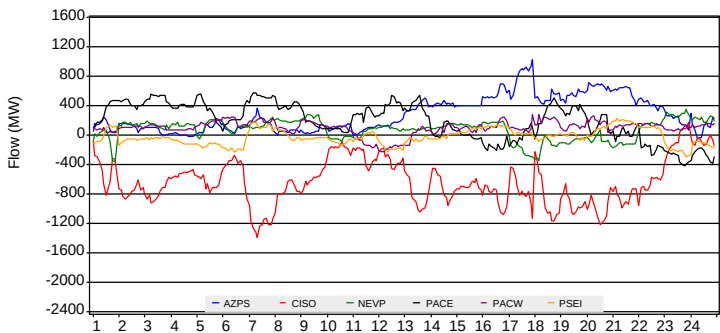
RTD ELAP LMPs and System Energy Prices



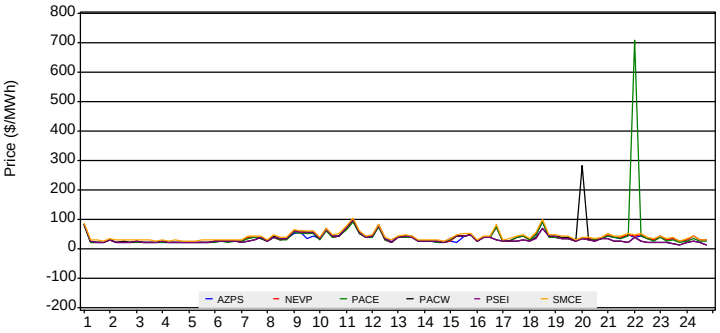
RTD EIM Transfer Limit Shadow Price



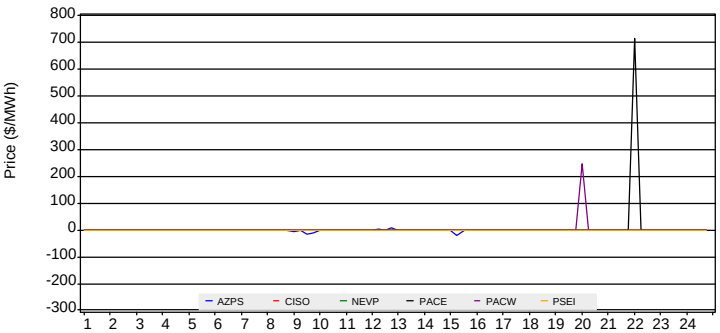
RTD EIM Transfer Flow



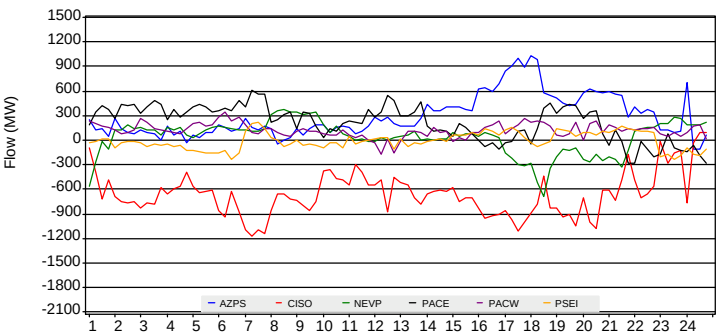
FMM ELAP LMPs and System Energy Prices
