

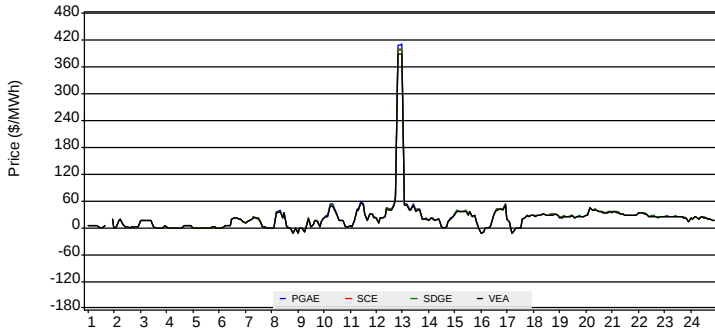

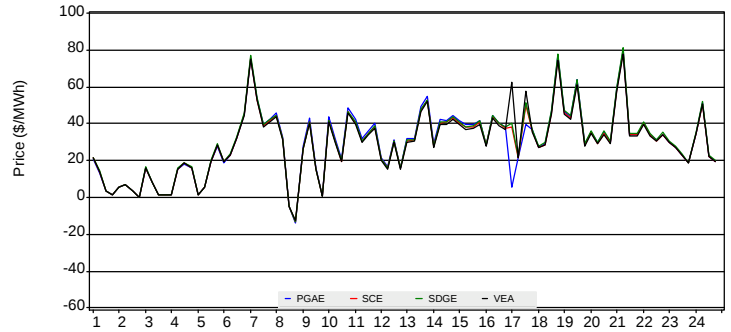
RTD Default LAP LMPs



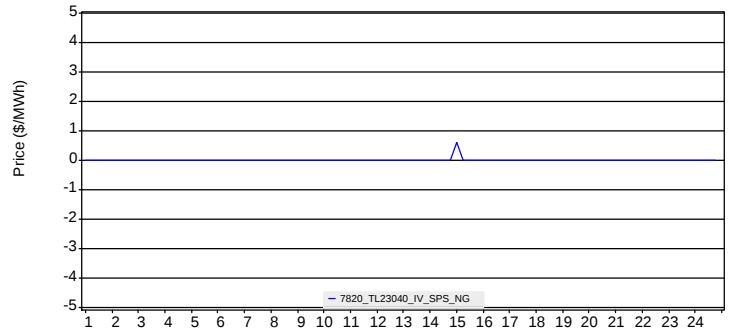
Selected RTD Nomogram Shadow Prices

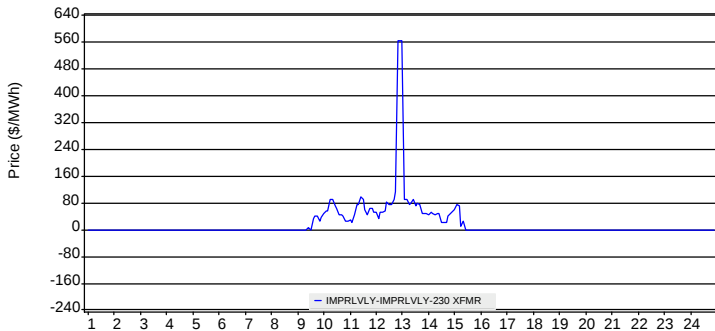

Selected FMM Nomogram Shadow Prices



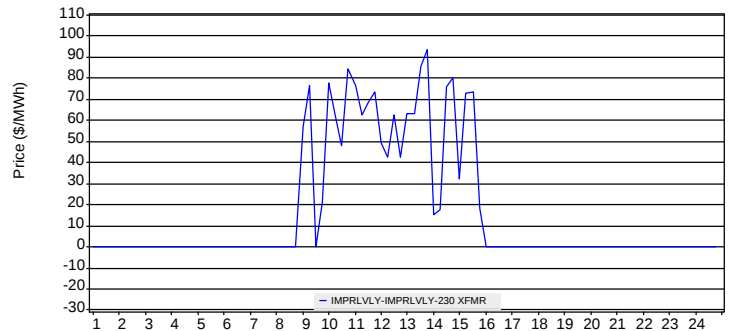
Selected RTD Transmission Line and Transformer Shadow Prices

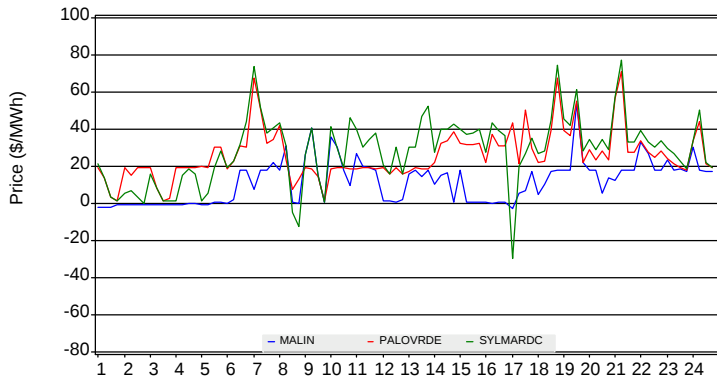

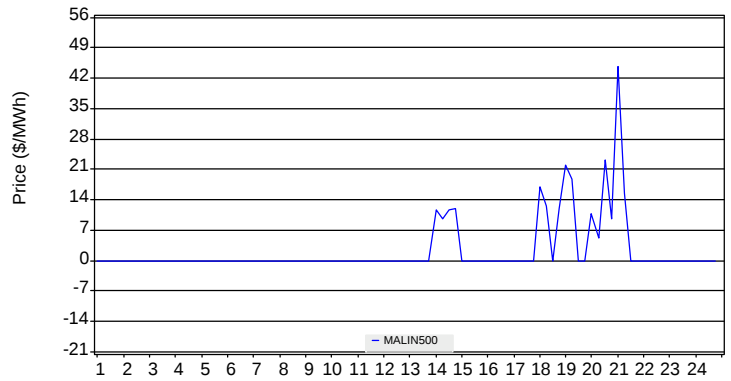

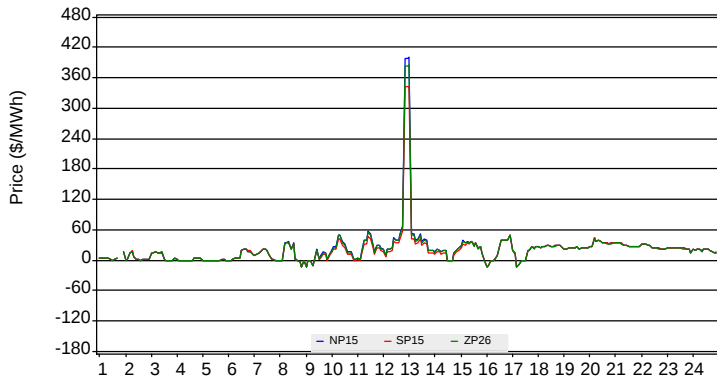
FMM Tie LMPs



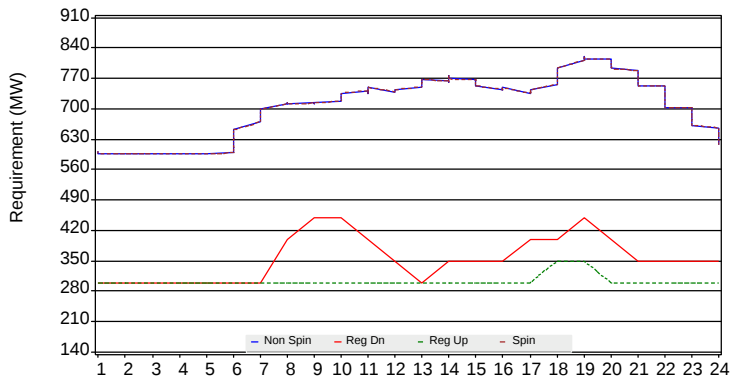
FMM Selected Tie point Shadow Prices



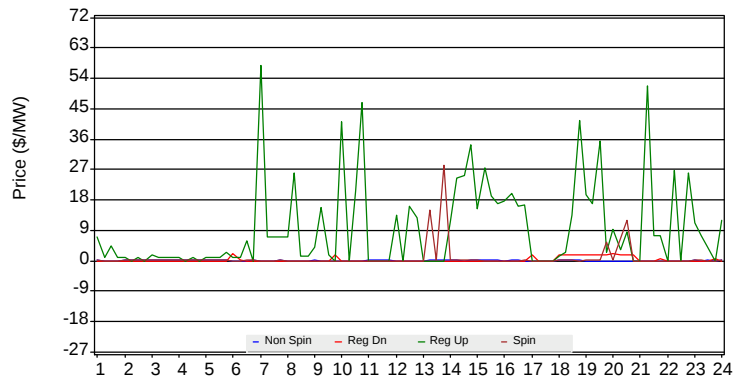
RTD Trading Hub LMPs

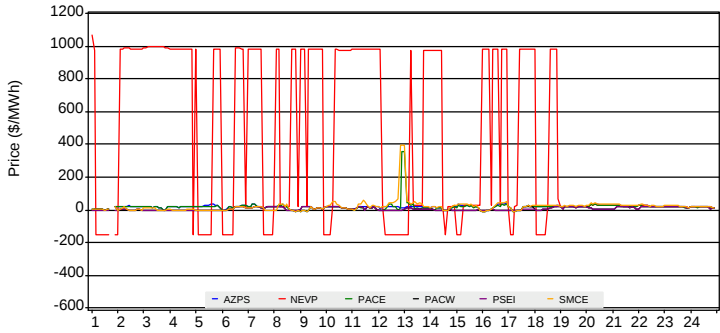

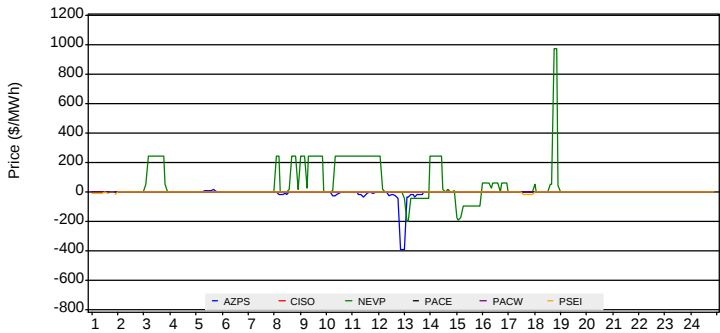

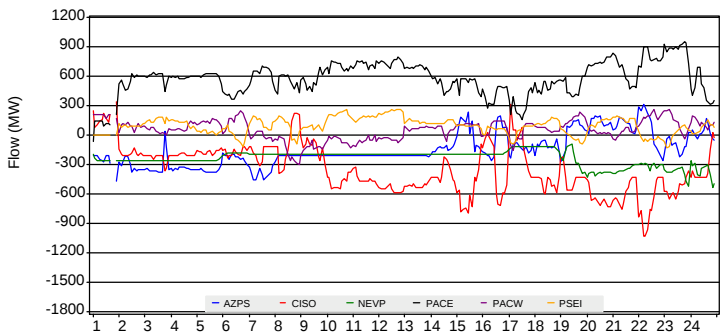
RTD ELAP LMPs and System Energy Prices



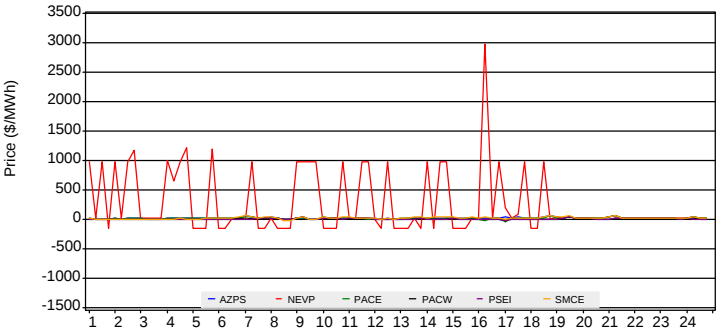
RTD EIM Transfer Limit Shadow Price



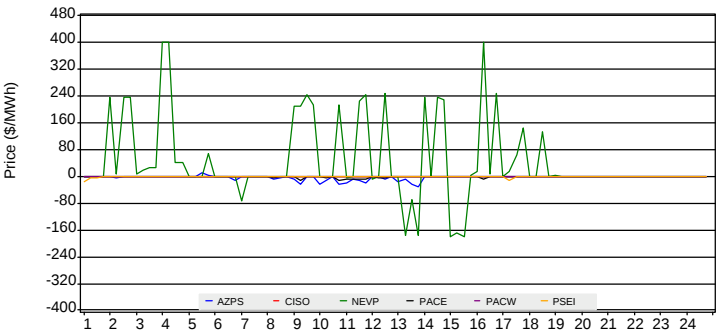
RTD EIM Transfer Flow



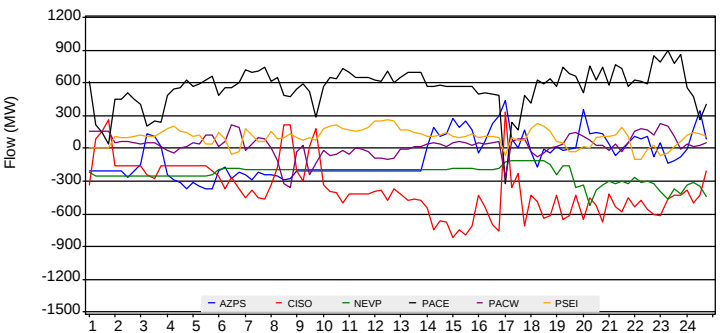
FMM ELAP LMPs and System Energy Prices
