I. Background

A Market Disruption is an action or event that causes a failure of a CAISO Market, related to system operation issues or System Emergencies.¹ Pursuant to Section 7.7.15 of the CAISO Tariff, the California Independent System Operator Corporation (ISO or CAISO) can take one or more of a number of specified actions in the event of a Market Disruption, to prevent a Market Disruption, or to minimize the extent of a Market Disruption. The ISO interprets this to mean that a Market Disruption occurs and the ISO is obligated to report its occurrence in any of the following circumstances:

- When any of the ISO market processes fail to publish, including the Integrated Forward Market (“IFM”), Residual Unit Commitment (“RUC”), Hour-Ahead Scheduling Process (“HASP”), Real-Time Unit Commitment (“RTUC”), or Real-Time Dispatch (“RTD”) processes;
- When the ISO manually overrides the closing of the Day-Ahead Market; or
- Any time that the ISO removes Bids from a CAISO Market to prevent a Market Disruption or to minimize the extent of a Market Disruption.

The Market Disruption report contains the following information:

- The frequency and types of actions taken by the ISO pursuant to Section 7.7.15;
- The nature of the Market Disruptions that caused the ISO to take action, or the Market Disruptions that were successfully prevented or minimized by the ISO as a result of taking action, and the ISO’s rationale for taking such actions pursuant to Section 7.7.15;
- Information about the Bids (including Self-Schedules) removed pursuant to Section 7.7.15 (*i.e.* megawatt quantity, point of interconnection, specification of the Day-Ahead versus Real-Time Bid, and Energy or Ancillary Services Bid); and
- The ISO’s rationale for its removal of Bids (including Self-Schedules) pursuant to Section 7.7.15.²

II. Report on Market Disruptions Occurring from July 16, 2010 through August 15, 2010

The ISO's report on Market Disruptions that occurred during the time period from July 16, 2010 through August 15, 2010, is provided in Table 1 and Attachment A below. Attachment A includes an entry for each reportable Market Disruption event and each entry also indicates:

- (1) The date of the Market Disruption;
- (2) The hour and Dispatch Interval when the Market Disruption ended;
- (3) The type of CAISO Market in which the Market Disruption occurred;
and
- (4) A description of the nature of the Market Disruption, the nature of any actions taken by the ISO, the rationale for such actions, and the Market Disruption prevented or minimized as a result of taking such actions.

For each of the CAISO Markets, Table 1 lists the number of Market Disruptions and the number of times that the ISO removed Bids (including Self-Schedules) during the time period covered by this report. As shown in Table 1, there were a total of 141 Market Disruptions for the reporting period, all of which occurred in the Real-Time Market (RTM). The number of Market Disruptions increased by 12 compared with the August 2010 report. Table 1 also indicates that the ISO did not remove any Bids (including Self-Schedules) in any of its markets during the reporting period.

Table 1 and Attachment A indicate that there were 27 instances of RTUC failures, including four HASP failures. The count of RTUC failures and HASP failures remained approximately same compared with the August 2010 Report. Most of the RTUC failures (including the HASP failure) were caused by software application failure, compensating injection, software application not running, database issue or bid transfer issue. The frequency of RTD failures increased to 114 from 100 such instances reported in the August 2010 Report. Most of the RTD failures were due to software application failure, software application timing out, database issue or broadcast results failure. RTD failures accounted for approximately 80 percent of all of the Market Disruptions during this reporting period.

On July 22, there were six RTD failures due to broadcast results and four other RTD failures occurred due to infeasible solution. On July 29, four RTUC failures occurred due to bid transfer. Another RTD failure occurred on that day

due to broadcast results. On July 30, there were six RTUC failures and one HASP failure due to software application failure and compensating injection.

On August 2, there were four RTD failures and one RTUC failure, due to planned patch deployment. Seven other RTD failures on that day were driven by the failure of broadcast results. On August 4, three RTUC and one RTD failures occurred either due to compensating injection or due to emergency patch deployment for compensating injection. Two other RTD failures occurred each due to database maintenance and failure to broadcast results. On August 5, three RTD failures and one RTUC failure occurred due to patch installation maintenance. Three other RTD failures occurred on the same day and then advisory results were sent out. On August 6, there were four RTD failures due to broadcast results and three other RTD failures occurred due to software application timing out.

Real-Time Unit commitment (RTUC) Interval 1: The first of a series of four market runs conducted every Trading Hour in advance of the Operating Hour. In this run the ISO conducts the Market Power Mitigation and Reliability Requirement Determination for submitted Bids, which applies to all of the Real-Time Market processes for the given Trading Hour. In this interval the ISO also conducts the procurement of incremental Ancillary Services from internal resources and dynamic external resources.
