**ANSWER OF THE
CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION
TO MOTION FOR EXTENSION**

Pursuant to Rule 213 of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.213, the California Independent System Operator Corporation ("CAISO") submits this Answer to the "Motion of PacifiCorp for Extension of Comment Deadline" filed by PacifiCorp in the above identified proceeding on September 25, 2007.

The proceeding concerns the unexecuted Operating Agreement between the CAISO and PacifiCorp that the CAISO filed on September 14, 2007. PacifiCorp requests that the October 5, 2007, deadline for comments (and presumably for interventions and protests) that the Commission established in its September 20, 2007, Notice be extended to October 19, 2007. PacifiCorp states that an extension is appropriate because the parties in Docket Nos. ER07-882 and ER07-967 are engaged in settlement negotiations that could render the Operating Agreement unnecessary. Further negotiations are scheduled for the week of October 8.

The CAISO neither opposes nor supports the request. The CAISO recognizes that other parties in the proceeding may object to the extension, and

trusts that the Commission will give due consideration to the arguments of PacifiCorp and the other parties.

As the Commission is aware, the CAISO has requested that this proceeding be consolidated with Docket Nos. ER07-882 and ER07-967. Regardless of whether the Commission grants PacifiCorp's motion, the CAISO asks that the Commission act expeditiously on the request for consolidation.
