STATUS REPORT TO THE COMMISSION

(Issued December 31, 2003)

TO THE COMMISSION AND THE CHIEF JUDGE:

1. On July 8, 2003, pursuant to the Commission's Order of May 2, 2003, 103 FERC ¶ 61,122 (2003), Commission Trial Staff filed a Motion to join seventeen qualifying facility ("QF") dockets to the consolidated *Investigation of Certain Enron-Affiliated QF's*, Docket Nos. EL03-47-000 and EL03-117-000 ("consolidated docket"). On July 11, 2003, the Chief Administrative Law Judge issued an order adding all seventeen QFs to the consolidated docket.
2. On July 22, 2003, the Chief Administrative Law Judge issued orders establishing settlement procedures and assigning three separate settlement judges to address the seventeen QFs, which were added to the consolidated docket on July 11, 2003.

3. On December 11, 2003, I certified an uncontested settlement in *Las Vegas Cogeneration Limited Partnership*, Docket No. QF89-251-008, to the Commission for its review. The remaining above-captioned dockets, with Docket EL03-47-001,¹ are currently continuing in settlement procedures.²

4. In total, eight remaining QFs are continuing in settlement procedures. I will keep the Commission apprised of all further developments in this proceeding in a status report on January 30, 2004.
