Dear Secretary Boergers:

On February 24, 2000, the Commission accepted the partial Offer of Settlement filed by the California Independent System Operator Corporation ("ISO") in the above-captioned dockets. 90 FERC ¶ 61,178 (2000). The tariff sheets provided in the Offer of Settlement were based on the ISO Tariff as approved by the Commission through Amendment No. 20 (including the ISO's Amendment No. 14 compliance filings). Since the Offer of Settlement was filed, the Commission has conditionally accepted, in whole or in part, subsequent amendments to the ISO Tariff, including Amendment No. 21, 89 FERC ¶ 61,169 (1999), Amendment No. 22 and the Amendment No. 22 compliance filing, 89 FERC ¶ 61,229 and 90 FERC ¶ 61,315 (2000), Amendment No. 23, 90 FERC ¶ 61,006 (2000), Amendment No. 25, 90 FERC ¶ 61,316 (2000), and Amendment No. 26, 90 FERC ¶ 61,345 (2000).¹

The enclosed compliance filing contains revised tariff sheets that update the ISO Tariff sheets from the Offer of Settlement to incorporate the terms of these recent amendments. The ISO has also made the change requested by the Metropolitan Water District of California to Section 2.2.4.6.² The enclosed compliance filing also contains

black-lined Tariff provisions that reflect this change to Section 2.2.4.6 and that reflects Unresolved Issues settlement changes to Tariff provisions that have been modified by subsequent amendments to the ISO Tariff accepted by the Commission. In addition, the ISO will post an updated conformed version of the ISO Tariff incorporating the revisions approved in the Unresolved Issues settlement and the Commission's orders on these subsequent ISO Tariff amendments on the ISO Home Page.

Copies of this letter and the enclosures were served today on those persons on the restricted service list adopted by the Commission in this proceeding.

Also enclosed is an extra copy of the filing to be date-stamped and returned to our office by the messenger.
