Re: **Update on results of reliability must-run contract extensions for 2022**

This memorandum does not require Board action.

EXECUTIVE SUMMARY

At its September 22-23, 2021, meeting, the ISO Board of Governors authorized Management to extend the existing reliability must-run contracts for the Dynegy Oakland, LLC, Starwood Energy Group, CSU Channel Islands Site Authority, Midway Sunset Cogeneration Company and KES Kingsburg, LP generating units listed in *Attachment 1* through calendar year 2022, following Management's review of load serving entities' September preliminary resource adequacy showings.

The Agnews Power Plant, owned by O.L.S. Energy-Agnews, Inc., for which the Board approved, at its July meeting, a local reliability must-run designation for 2022, has entered into a resource adequacy contract for the full amount of their available capacity through 2022 and will be available to the ISO without the need for a reliability must-run contract.

Management has reviewed the resource adequacy showings and has extended the reliability must-run contract with Dynegy Oakland for Oakland units #1 and #3, Starwood Energy Group for Greenleaf II Cogen, CSU Channel Islands Site Authority for Channel Island Power unit, Midway Sunset Cogeneration Company for Midway Sunset Cogen units A, B and C and KES Kingsburg, LP for Kingsburg Cogen unit. The Oakland units are required to meet the 2022 local capacity needed for the Oakland sub-area within the Bay Area local area. Greenleaf II Cogen is required to meet the 2022 local capacity need in the Drum-Rio Oso sub-area of the Sierra local area. Channel Islands Power, Midway Sunset Cogen units and Kingsburg Cogen are required for the ISO to meet the 2022 system-wide reliability needs. None of these resources were included in any load serving entity's preliminary resource adequacy showing.
