### Amendments pending with FERC (not yet approved)

The following Tariff Amendment filings were submitted to FERC and are not yet approved by FERC and are ***not reflected in the posted version of the conformed tariff***. CAISO proposes to add a rule authorizing a “dual filing” in certain circumstances when no single proposed amendment is supported by both the Board and the WEM Governing Body (ER25-542).
